In 2011, 75 individuals were given shelter and support services. **Transitional Housing program-** IHN leases several transitional housing apartments in Montclair and East Orange, NJ. The transitional housing program provides a stable home for 12-24 months with ongoing case management and support services. In 2011, 31 individuals were in the transitional housing program and received weekly case management services. **Permanent Housing Program-** IHN provides follow-up case management services to families that have left the shelter program. Families leaving the shelter program may receive assistance with moving, security deposits,
